### Preamble

This Privacy Policy explains what information of yours will be collected by us and stored on our servers when you make use of the Website and how the information will be used.

This Privacy Policy statement is made in accordance with company’s Confidentiality and Personal data Protection Policy and may be updated from time to time and therefore we ask you to check back periodically the most updated form of Privacy Policy statement as indicated below. Your continued use of this Website after this Privacy Policy has been amended shall be deemed as your continued acceptance of the terms of this Privacy Policy, as amended.

### Information Collected

#### Personal Information

We may collect and store any information you explicitly provide or enable us to access, whether via the Website, software made available for your use in connection with the Website (“Software”), third party login services and accounts, or direct communication (for example, in the process of registration to the Website services, filling forms or submitting enquiries), including, for example, information which identifies or relates to you personally, such as your name, career interests, and so on (“Personal Information”).

#### Non-Personal Information

We collect and aggregate non-identifying information regarding your use of our Website, including, for example, type of device through which the Website is accessed, pages browsed, search inquiries, services that interested you or which you have utilized, the type of browser you are using and its settings, your IP address, the URL you have come from and the time spent at that URL, content of Cookies set by us (as further detailed below) and your domain type and server (“Non-Personal Information”).
